SUMMARY

The Board of Directors authorized staff to prepare and mail a water supply survey to all properties within the "Johnson Valley" area. The layout and content of the survey was reviewed by both standing committees. Approximately 1,165 surveys were mailed into two separate areas of the Agency. Approximately 390 were returned. The responses will be tabulated at the meeting.

RECOMMENDATION

That the Committee tabulate the survey responses and report the results to the full Board on August 24, 2010.

BACKGROUND/ANALYSIS

The Board of Directors authorized staff to prepare and mail a water supply survey to all properties within the "Johnson Valley" area (see attached). The layout and content of the survey was reviewed by both standing committees. The surveys were anonymous except that they were colored based on tax rate area. Tan survey cards represent properties very near to the existing pressurized water system. Blue survey cards represent properties further to the west and farther away from the existing pressurized water system (Figure 1).

The "blue" survey area represents 886 properties. There were 324 blue survey cards returned for a response rate of approximately 36%.

The "tan" survey area represents 236 properties. There were 70 tan survey cards returned for a response rate of approximately 30%.

According to our research, response rates vary widely for surveys. Customer satisfaction and market research surveys, like the Johnson Valley Water Supply Survey, often have acceptable response rates in the 10% to 30% range. The majority of mail surveys distributed achieve a

response rate between 15% and 25%. Therefore, the Johnson Valley Water Supply Survey could be considered a reasonable representation of the property owners' opinions.


The survey response card provided space for written comments. The most common written comment was that the property owners were not provided any cost projections. The cost of a pressurized water supply system is based on many variables such as the size of the system (miles of pipeline) and appurtenances such as reservoirs, pump stations or water supply wells that might also be needed to satisfy demand, delivery and storage requirements. Therefore, it is nearly impossible to estimate the individual property cost share in a new water system until a proper engineering analysis is completed. The intent of the survey was to determine if a majority interest in a pressurized water system exists in order to justify initiation of a cost analysis. Of course, this project would entail a specific benefit area or assessment district from which these funds would have to originate. The property owners would have to approve this though a formal process described in the Government Code.

As directed by the Board, staff only counted the returns to determine the response rates. There has been no tabulation of the actual responses. The responses will be tabulated at the meeting.

The Board of Directors will be asked to "receive and file" the tabulated survey responses and provide further direction to staff on August 24, 2010.
