PUBLIC EMPLOYEE PERFORMANCE EVALUATION

Director McBride reported the Board to give the closed session report of the General Manager's evaluation during that open session Agenda item.

CONFERENCE WITH LABOR NEGOTIATORS

Director McBride reported the Board set the contract negotiation parameters for the General Manager Performance/Compensation "2-Member" Ad Hoc Committee (which

consists of Vice President Coulombe and Director McBride), so the committee would know the desires of the Board to enable them to negotiate with the General Manager.

PERFORMANCE EVALUATION OF THE GENERAL MANAGER

Director McBride reported that in the past the Agency did not have a written format for the performance appraisal. This time, the Board used a written format in order to provide for a thorough examination of the General Manger's performance. The Board members independently completed a 6 page performance appraisal, and the Ad Hoc committee combined the independent performance appraisals into one appraisal which all Board members signed. The Board is extremely pleased with the General Manager. General Manager West got an excellent performance appraisal.

Public comment:

Duane Lisiewski, of Flamingo Heights, questioned when the public gets a chance to look at the performance evaluation and would like to know the format (blank form) used to do the evaluation.

General West commented the details/results about the performance evaluation are confidential. She will consult with the Agency's General Counsel about releasing the blank forms.

President Burkhart commented if the Agency's attorney agrees that the blank form can be released to the public, the Agency will make it available to the public.

EXTENSION OF GENERAL MANAGER'S EMPLOYMENT AGREEMENT BEYOND THE EXPIRATION DATE OF APRIL 30, 2011

Director McBride reported it is not likely we are going to be able to finish the contract negotiations with General Manager West by the time her contract expires. Therefore, the Ad Hoc Committee is asking the Board for more time to complete the contract negotiations.

Public comment:

Duane Lisiewski, of Flamingo Heights, questioned how long it was going to take to complete the labor negotiations for the General Manager.

The Board commented that the Agency is extending the current contract indefinitely until the negotiations are complete to allow an appropriate amount of time to negotiate the new contract with General Manager West.

General Manager West commented that the actual language of her existing contract states" if the parties are in negotiations of arrangements to continue employment of the general manager beyond the termination date then the existing contact can continue to be in full force and effect until the negotiations are either "A" are terminated or "B" the contract is replaced or "C" the terms of this contract are continued.

Gerry Kay, of Yucca Valley, wanted to discuss the Agency's audit.

President Burkhart commented the Board cannot discuss the audit as it is not part of this agenda item.
