On March 12, the Local Agency Formation Commission came to Landers for the citizens of County Service Area W-1 (Landers water). The question of the future sphere of influence for Bighorn-Desert View Water Agency was on the agenda. LAFCO deserves kudos for deciding to hold a community meeting. Kudos to the many W-1 customers who took the time to attend that meeting! To the surprise of many who had received such news, Monday's meeting was not convened to determine the sphere of influence for Yucca Mesa. We would like to dispel other "myths" now.

Myth 1: The expansion of the sphere of influence is a "takeover" of W-1 by BDVWA. The reality is that a sphere of influence is a planning tool for future provision of water services. It is true that once a sphere is designated, then reorganization could take place by dissolving W-1 and annexing services to BDVWA: Small in size, Bighorn Mountains and Desert View reorganized in 1990. Don't be fooled; the ultimate decision for reorganization will rest with the voters of the area under a standard protest process. Myth 2: If W-1 does (eventually) reorganize and annex service to BDVWA, then W-1 properties will be forced to pay bond debt belonging now to BDVWA customers. The fact is that state law prohibits such a practice and dictates that "indebtedness is the legal obligation of only the lands and areas which approved such indebtedness upon" themselves.

If you received a white "ballot" card in the mail, then BDVWA encourages you to respond to LAFCO directly. Whether you are "for," "against" or "uncertain" about your sphere of influence, the time is now to let LAFCO know your opinion so mail that card in today!

WHEREAS, a service review mandated by Government Code 56430 and a sphere of influence update mandated by Government Code 56425 have been conducted by the Local Area Formation Commission of the County of San Bernardino (Commission) in accordance with the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (Government Code Section 56000 et. seq.; and

WHEREAS, a sphere of influence is a planning boundary that sets the "probable physical boundaries and service area" of a special district such as the Bighorn-Desert View Water Agency (Agency); and

WHEREAS, a hearing by the Commission was conducted on January 18, 2012, to consider the service review and sphere of influence update for the Agency and voiced its intent not to expand the Agency's sphere of influence into the area of County Service Area (CSA) 70 W-1 identified as Area #2" and other areas on the attached Figure No. 1; and

WHEREAS, the January hearing was continued to February 15, 2012; and

WHEREAS, on February 15, 2012, Agency staff and a board member presented information to the Commission that there is interest from some landowners within CSA 70 W-1 and the "cross" territory who wish to be included in the Agency's sphere of influence and requested that the "cross" territory be more thoroughly considered; and

WHEREAS, the Agency is presently serving a portion of the existing CSA 70 W-1 through an out-of-agency service agreement dated December 16, 1997. This arrangement was instituted when CSA 70 (County Special Districts Department) decided not to repair a failed portion of their distribution system intended to serve these properties; and

WHEREAS, given that information, the Commission voted to postpone adoption of the service review and sphere of influence update resolution pending a community outreach meeting to hear from affected residents of the area; and

WHEREAS, the Commission held a community meeting on March 12, 2012 in Landers, CA to provide information and seek direct input; and

WHEREAS, the Agency distributed a postage-paid "response card" addressed directly to the Commission to the affected properties and registered voters requesting their direct input on the expansion of the sphere of influence over their service area; and

WHEREAS, a sphere of influence does not change the property owner's existing water purveyor but is used as a planning boundary; and

WHEREAS, the service review and sphere of influence is the most costeffective means of completing the first step towards possible future changes in water service area boundaries; and

WHEREAS, Government Code Section 57000 provides the procedures and requirements allowing affected properties to protest the completion of any reorganization and annexation of additional territories into the Agency.

NOW, THEREFORE, THE BOARD OF DIRECTORS HEREBY RESOLVES:

- To approve and support the expansion of its sphere of influence of "Area 2" as outlined in the LAFCO 3148 Service Review and Sphere of Influence Update report dated January 9, 2012, recommendation No. 2 (p. 74); and
- 2. To encourage the Commission to acknowledge the value of the service review and sphere of influence process in setting the "planning boundary" for the Homestead Valley community; and
- 3. To urge the Commission to grant the expansion of the sphere of influence over "Area 2" as recommended by the Commission staff in the January report.




Figure 1 – Depicting the outline of "Area 2" which includes County Service Area 70 W-1 (Landers) service territory and the "cross area" and "other area" which are currently not located within a sphere of influence of a water purveyor.



By distribution of this letter, the official voting process for the Regular Special District Member of the Local Agency Formation Commission shall commence. Attached is the ballot for the selection of this position. Pursuant to the provisions of Government Code Section 56332, the voting period will be for 32 days, commencing as of today's date and ending on **Friday**, **April 20**, **2012**. The voting instructions for these selections are as follows:

- Each District may vote for one candidate only. The vote shall be cast as directed by the Board of Directors of the District through consideration at a Board Hearing and a roll call vote. A copy of the information provided by the candidates is included for your information.
- 2. The signed original ballot, with the name of each voting Board Member outlined, must be received in the LAFCO Office by 5:00 p.m. on April 20, 2012. If a faxed copy of the ballot is provided by the April 20 deadline, the original signed copy must be received by 5:00 p.m. on April 27, or the ballot will be declared invalid.
- 3. Twenty-six (26) ballots are required to be received for selection of the Special District position. In the event of a tievote, or if no candidate receives the required 26 votes, a runoff election will be held between the top two candidates. This will again involve a minimum 30 day voting period.

SUMMARY

At the February 10, 2012 Board Workshop staff was directed to evaluate a cost of living adjustment (COLA) to the Range and Step Scale referenced in the Employee Handbook. It was noted that the Agency hasn't authorized a COLA since January 2008.

The Finance/Public Relations/Education/Personnel Committee reviewed the matter on March 7, 2012 and recommended that the Board use the Social Security Administration COLA Adjustment tables now and in the future. In addition, the Committee agreed that implementation of cost of living increases should be tied to the fiscal year budget which begins July 1.

RECOMMENDATION

The Board considers taking the following action(s):

- 1. Authorize inclusion of a Cost of Living Adjustment of 3.6% based on the Social Security Administration Cost-of-Living Adjustment publication for all employees in the fiscal year 2012/13 budget; and
- 2. Direct staff to revise Employee Handbook to define the methodology for determining the Cost of Living to be the Social Security Administration Cost-of-Living Adjustment publication in the future; and
- 3. Direct staff to revise the Employee Handbook to define the implementation period for any future cost of living adjustment to be the first payroll following July 1; and
- 4. Bring revised Employee Handbook Resolution to the Board for formal adoption at a regularly scheduled Board of Directors meeting.

BACKGROUND/ANALYSIS

At the February 10, 2012 Board Workshop staff was directed to evaluate a cost of living adjustment (COLA) to the Range and Step Scale referenced in the Employee Handbook. It was noted that since the approved COLA in January 2008, the BOD has informally adopted a 0% COLA in subsequent years irrespective of the CPI. The BOD is not required to provide the adjustment automatically; setting the adjustment at 0% or something less or something more than the published index is a board decision.

The Employee Handbook states that the Board, at its discretion, may grant a percentage cost of living adjustment to the Range and Step Scale each year to be effective on or about January 1. In addition, the general manager's contract states she will receive the same COLA when all other Agency employees receive such an increase.

There is no specific guidance in the Employee Handbook on how to calculate the COLA however in 2008 the Bureau of Labor Statistics Consumer Price Index (CPI) data was utilized. This database is used routinely by other agencies for this purpose.

The Board has missed the opportunity to make a cost of living adjustment effective January 1 so staff recommends that if Board wishes to approve the adjustment then it should be at the beginning of the next fiscal year. The first step in using the CPI to propose a percentage increase is to determine the date range. The CPI is reported per month. It was stated in the minutes from 2008, that the COLA was based on a twelve month period ending November 2008 and the increase was approved on January 22nd.

The relevant CPI table was reviewed with the Committee on March 7, 2012. Depending on the date range a different result will be calculated. If one uses the "annual" figure then the COLA is calculated at 2.9%. Using any given date range the COLA is calculated between 1.9% and 3.4%.

An alternative index was proposed to the Committee which is to follow the COLA given by the Social Security Administration. It is essentially tied to the cost-of-living, though on a national scale. Staff recommends this index since it is an index many constituents can relate to. There is only one figure provided per year (see attached). For January 2012, the adjustment is 3.6%.

Based on the current budget, each 1% increment of the COLA will have a fiscal impact of \$3,850 per year.

The Committee directed staff to bring the matter before the full board on April 3, 2012 recommending that the Board use the Social Security Administrative annual COLA Adjustment method and to implement any approved adjustments in July commensurate with the beginning of the fiscal year. Should the Board approve such changes in methodology then a Resolution concerning modifications to the Employee Handbook can be brought to the full Board at a later date.

History of Automatic Cost-Of-Living Adjustments

The 1975-82 COLAs were effective with Social Security benefits payable for June (received by beneficiaries in July) in each of those years. After 1982, COLAs have been effective with benefits payable for December (received by beneficiaries in January).

Subject: Review Options for Designating Fund Accounts for Monies Retained in the Local

Agency Investment Fund

SUMMARY

Staff and the Finance/Public Relations/Education/Personnel Committee recommend that the board establish designated fund accounts to differentiate the prescribed uses for monies retained in the Local Agency Investment Fund (LAIF).

RECOMMENDATION

The Board considers taking the following action(s):

1. Direct staff to modify the general ledger separating the Local Agency Investment Fund (LAIF) into sub-accounts and bring a Policy back to the Board at a future date.

BACKGROUND/ANALYSIS

Staff recommends that the board establish designated fund accounts, general ledger sub-accounts, to differentiate the prescribed uses for monies retained in the Local Agency Investment Fund (LAIF).

The LAIF account is used to hold monies that are not immediately needed because LAIF pays interest whereas the Union Bank checking account does not.

Staff believes more transparency is needed in financial reporting to demonstrate where the monies in LAIF are expected to be expended. The following general ledger sub-accounts categories are recommended at this time and should be brought to the board in the form of a policy. The purpose of the policy would be to define the sub-accounts and to set goals for reserve funds, clearly describe authorization for the use of the sub-accounts and outline how they will be reported. However, the policy should not be so restrictive that it prohibits flexibility and ease of access. Reserves are there to help the organization operate its programs and services, not create an untouchable bank balance for everyone to admire.

General Ledger Sub-account categories proposed and known current balances:

Total LAIF Account Balance: \$948,000

Customer Deposits (restricted): \$50,000

Basic Facilities Charges Accumulated: \$27,196 Encumbered for Approved Projects: \$100,000

Emergency Contingencies Fund: \$0 Replacement & Refurbishment Fund: \$0

Unencumbered Cash: \$770,804

Monies collected from new service connections, known as the Basic Facilities Charge, is restricted for new system improvements (ie. not repairs). Once the Agency determines the projected goals for an emergency contingencies fund and Replacement & Refurbishment Fund then monies can be reallocated from the Unencumbered Cash account. The remaining unencumbered cash can provide for Capital Improvement Projects, budget shortfalls, etc.

The Committee recommended setting goals for the Emergency Contingencies Fund and the Replacement and Refurbishment Fund between \$100K and \$200K respectively. However, while there is sufficient funding to populate these funds to that ceiling perhaps the goals are best achieved over a period of time.

Staff seeks approval from the Board to create the general ledger sub-accounts now and to proceed with development of a written policy regarding the LAIF cash account to be brought back for formal approval.





SUMMARY

Attached is the report establishing the Appropriation Limit for Fiscal-Year 2011/12. The appropriation limit shall be adopted by the Board by Resolution but prior to adoption Government Code Section 7910 requires that the calculations made to determine the Agency's appropriation limit be made available to the public for at least 15 days prior to the date the Board considers adoption of the Resolution. The Appropriation Limit was posted on February 29, 2012

The FY 2011/12 budgeted revenue for property tax is \$104,200 which does not exceed the calculated Appropriation Limit of \$131,706.18.

RECOMMENDATION

The Board considers taking the following action(s):

1. Adopt Resolution 12R-XX establishing the Appropriation Limit of the Agency for the fiscal year July 1, 2011 – June 30, 2012 pursuant to Article XIIIB of the California Constitution.

BACKGROUND/ANALYSIS

Each fiscal year, it is necessary that the Agency calculate the appropriation limit as required by Article XIII B of the California Constitution and Section 7910 of the Government Code. The appropriation limit sets the amount of property taxes the Agency can expend.

The factors used to calculate the limit are the percentages for change in population and the per capita personal income as released by the California Department of Finance.

Calendar year information is used to determine the percent change in population growth. The Agency's change for the year of 2010 was .97%. Fiscal year information is used to determine the percent change in California personal income. The percent change of California personal income for fiscal year 2010 was 2.51%.

The formula, as shown on the next page, used to calculate the appropriation limit is population growth times the per capita personal income times the prior year's limit. Based on this formula, Bighorn-Desert View Water Agency's appropriation limit for FY 2011-12 is \$131,706.18. The FY 2011/12 budgeted revenue for property tax is \$104,200 which does not exceed the appropriation limit.

On April 22, 2012 the Morongo Basin Conservation Association will hold its second annual *Desert-Wise Landscape Tour.* The purpose of the event is to educate the community on using water and energy in the desert responsibly. Last year the tour included 20 private residences throughout the Morongo Basin and 4 commercial gardens.

This year the tour features 4 homes located within BDVWA's service area in Flamingo Heights.

MBCA is seeking partnership funding to offset the total estimated program cost of \$3,340. They have secured \$1,500 in support from the Alliance for Water Awareness and Conservation (AWAC) and have asked if BDVWA would like to provide partial or full support to cover printing costs of \$900. A recent press release and last years program is attached to demonstrate the quality of the publication and information provided.



At 2,600', the property is perimetered by a windbreak/privacy screen of drought-tolerant evergreens native to the Basin and surrounding mountains. Inside the perimeter are long-lived indigenous specimens like Mojave yucca, wild plum, and ephedra, all retained during construction; other Southwest, drought-tolerant plants were added. Lush and water-efficient toyon, strawberry tree and holly-leaf cherry flonk the dwelling.

The property receives an annual broadcast of native plant seeds to assist reestablishment of natural ground cover and foliage.

Another rock-way leads under a drooping cat claw acacia into a large plaza reminiscent of Old Spain. Tiers of planters are filled with sage, lavender and roses. Beyond the courtyard is a set of step-stones climbing to a petite oasis-pond in the rocks. The water drops into a lower pool and trickles down rocks to a recycling point.

The owners have since re-built the home, and continue efforts to restore the landscape. Transplanted juniper, Joshua Trees, yucca and cholla are beginning to resemble some of the former beauty. Larger transplants anchor the landscape; drought-tolerant pine have replaced the pinyon pines. Native nursery plants, i.e. buckwheat, ephedra, scrub oak, apache plume, holly-leaf cherry, and sugar bush, augment the open spaces. Nestled among the boulders, a pond once again nurtures wildlife. Water from the private well is not metered, but water usage is up while youngling natives are nursed to sustainability.





house Resources at a Cost Savings to the Agency of Approximately \$8,900

SUMMARY

Staff, working cooperatively with Hi Desert Water District (HDWD), County Special Districts Department (County) and Gubler Orchids, has obtained all the relevant data for the completion of the 2011 Ames Valley Water Basin Monitoring Report. The report is essentially data tables beginning in 1990 establishing the record for water production, water quality and water level measurements taken from various monitoring and production wells as prescribed by the Ames Valley Water Basin Agreement.

Although the Ames Valley Water Basin Agreement, the associated Stipulated Judgment and additional Amendments require the report to be prepared by an independent consultant, according to legal counsel the signatory agencies can waive that requirement. Hi Desert Water District concurs with the recommendation to complete the 2011 data report using inhouse resources and has submitted the attached letter supporting this decision.

Staff seeks approval from the Board to waive the requirement that the report be prepared by an independent consultant saving the Agency approximately \$8,900.

RECOMMENDATION

That the Board takes the following action(s):

1. Motion to waive the requirement for an independent consultant to prepare the 2011 Ames Valley Water Basin Agreement Data Evaluation Report using in-house resources at a cost savings of \$8,900.

BACKGROUND/ANALYSIS

The Ames Valley has been monitored under the Stipulated Judgment, Agreement and associated Amendments since 1990. Since 2000, HDWD has sought the ability to recharge their State Water Project (SWP) allocations from Mojave Water Agency (MWA) into the Ames Valley. Continuous monitoring of the Reche and Pipes sub-basins of the Ames Valley has shown a need for SWP in the Ames Valley to supplement the native groundwater supplies tapped by several municipal producers. In addition, there is growing concern for elevated uranium in the Ames Valley which can also be mitigated with SWP. BDVWA and HDWD, the only signatories to the existing Judgment, Agreement and associated Amendments, have

come to realize the existing judgment is no longer functioning for either party and have reached a new agreement. The new agreement is more protective of the Ames Valley by including County and imposing pumping caps more closely tied to actual basin conditions. This new cooperative agreement brings a recharge facility into BDVWA and all water percolated provides a 5% water transfer to BDVWA.

The Ames/Reche Groundwater Storage and Recovery Program and Management Agreement and associated Monitoring Program Plan have been executed by HDWD, BDVWA and most recently County of San Bernardino Board of Supervisors. Approval by MWA is imminent pending grant of the right-of-way license from the Bureau of Land Management. The license is needed to construct the Ames/Reche spreading grounds. In order to implement the Agreement, the Parties shall enter into a Stipulation to Enter an Amended and Restated Judgment which supersedes the Judgment and which embodies the terms and conditions of the new Agreement. County Zone W-1, County Zone W-4 and MWA will seek to intervene as Parties in the case and join in a joint motion of all Parties hereto for the entry of the Amended and Restated Judgment. Staff anticipates this process will be completed by the end of 2012. Therefore, the 2011 Ames Valley Water Basin Monitoring Report will be the last report associated with the existing Judgment, Agreement and associated Amendments. Both Agencies are committed to continued monitoring and reporting if the revised Judgment is not completed in 2012.

BDVWA and HDWD staff agrees that a 2011 Data Evaluation report be produced but utilizing an independent consultant to compile and summarize the data tables is of no value to the parties or the public. The data will continue to demonstrate that a physical solution which utilizes an outside water resource (ie SWP) to supplement the natural supply is necessary to achieve a sustainable water supply for the future.

A proposal in the amount of \$17,800 was received from Todd Engineers to complete the report this year. Staff at HDWD and BDVWA decided the cost proposed by Todd as well as the costs paid to the previous consultant, Wagner & Bonsignore, was unwarranted at this time. A local resident stated he was concerned that the Agency was not following the reporting protocols outlined in the Judgment, Agreement and associated Amendments, specifically the requirement for utilizing an independent consultant. Due to his concern, agency counsel advised the Board consider the matter and if so inclined, to waive said requirement.

Staff recommends the Board waive the requirement for an independent consultant to prepare the 2011 Ames Valley Water Basin Agreement Data Evaluation Report using in-house resources at a cost savings of \$8,900.

SUMMARY

The Agency recently received a repair estimate of approximately \$5,000 for the 2005 Ford F-150 pickup truck used daily by Mr. Rewal. The truck has more than 140,000 miles. Major maintenance such as timing belt has never been completed on this vehicle. Staff believes that maintenance of the vehicle is beginning to increase. Given the mileage and age of the vehicle staff recommended to the Finance/Public Relations/Education/Personnel Committee on March 7, 2012 that the vehicle be replaced. The Committee concurred with staff but requested that staff keep the purchase local and that quotes for a Dodge vehicle be sought to compare to the Ford vehicle.

Staff has solicited quotes from Yucca Valley Ford Center and Yucca Valley Chrysler Center and based on the lowest overall cost recommends the Agency purchase the 2012 Dodge Ram 1500 (four wheel drive) vehicle, the lowest price bid, for \$25,642.67. In addition to the purchase of the vehicle additional funds estimated at \$2,500 will be needed to replace the exterior locking tool box (which has reached the end of its useful life), relocate the communications radio, install necessary safety equipment and provide "spray-on" bed liner/protector.

RECOMMENDATION

The Board considers taking the following action(s):

- Authorize General Manager to purchase a 2012 Dodge 1500 (four wheel drive) pick-up truck from Yucca Valley Chrysler Center at the total price bid of \$25,642.67; and
