Fiscal Year 2015/16 Mid-Year Budget Review and Discuss Fiscal Year 2016/17 Proposed Rate Increases

General Manager West gave the staff report. West reviewed the status of the property tax lien accounts within the general ledger balance sheets.

West reviewed the operating revenue items, water sales and non-operating revenue which includes property tax liens. West noted administrative expenses are up partly due to public notification notices of conservation measures.

West handed out a preliminary draft Capital Improvement Plan (CIP). In reviewing the CIP, West reminded the Board this exercise looks at the replacement and refurbishment of the major infrastructure taking into account the installed cost and lifespan verses the monies needed to be collected in order to complete these projects.

Currently staff projects that revenues are still on track to exceed expenditures by \$183K and while this is good the CIP summary suggests the Agency should be exceeding expenditures by \$233K. This number is closer to helping the Agency collect funds needed to support and sustain the water infrastructure.
