# **Approval of Agenda**

# Resolution No. 17R-12 Fixing and Adopting the Agency's Budget for Fiscal Year 2017-2018

General Manager West began with reminding the Board that last year the Agency adopted a multi-year rate increase which "projected out" four years of expenses and rate increases intended to meet those goals. The fiscal year 2017/2018 budget includes the pre-approved rate increase from 2016.

West gave a brief power-point presentation on the proposed budget. Line items such as water sales have increased. West attributes the increase to the aggressive service line and meter replacement program within the Bighorn-Desert View system. West suggested that the Goat Mountain Territory will experience less water loss over the upcoming years as staff begins to replace the service lines and meters within that system.

West also reviewed the debt service payoffs scheduled over the next few years.

Operational expenses include higher salaries, additional equipment and building maintenance expense and fuel cost increases. Decreases in expenses consisted of employee health insurance premiums and lower Bureau of Land Management right-of-way rent.

West explained to the Board that the coming fiscal year budget will include a write-off of debt from the property tax lien process. The auditors and agency both agreed to begin writing off unpaid debt paid via the tax bills after seven years.

The Capital Improvement Program (CIP) will include phase two of the generator program, smaller motors on well pumps which will lower demand fees and replacement of pavement and the office and shop. CIP also includes replacement of one work truck and pipeline replacement within a small portion of the Agency.

Director Burkhart seconded the motion.
