Public Hearing: 2018/2019 Tax Bill – Delinquent Water Accounts

General Manager West gave the staff report. General Manager West explained that the 2018/2019 Tax Bill there were approximately 113 accounts, with a total outstanding debt of \$35,213.51 which is roughly \$10,000.00 less than last year (\$45,364.00). General Manager West goes on to explain that the reasons for the decrease from last year would be that more properties are being used and developed as well as more customers paying their bills on time. General Manager West described the process. First, the account holder is notified that their account is severely delinquent (90 days or later) and if they do not pay their bill then the Agency will attempt to make contact through a Public Notice in the newspaper. General Manager West explained that these accounts have until September 1st 2018, to pay us directly. After September 1st 2018, the Agency rolls these delinquent accounts up to the County and the customer account is adjusted accordingly. When the tax bill is paid through the County, the Agency then receives the money directly from the County. General Manager West mentioned that the delinquent account holders will also have to cover the fees associated with this process beginning with the page in the public Approved 08-28-2018

Notice (which totaled \$3,700.00). Director Staley asked why there are a few names listed twice in the delinquent account list. General Manager West explained that the reason for this most likely is that the customer has two water meters on one parcel. Director Staley was wondering why some of the delinquent account numbers were so small. General Manager West explained that even though the amount seems minuscule, the amount is owed to the Agency. Director Staley also asked if these were for unimproved or improved properties. General Manager West answered both, but she was unable to cite the number of each type. Director Staley was also wondering how many times the Agency tries to contact or reach out to any of the delinquent account holders and General Manager West explained that each receive a bimonthly billing statement, a bimonthly delinquent statement and the final notice of delinquency mailed in May.

Public comments: An anonymous member of the public asked if the Agency will be writing off any of these debts. General Manager West explained that these leans will be carried on the books for seven (7) years after which the remainder will be written off. She noted the amount was approximately \$1,500.00 for the 2010-2011 write off and will be presented to the Board in the next agenda item.

Adopt Resolution 18R-11 Ending the Levy and Collection of Ad Valorem Taxes within Improvement District No. 1 and Setting the Ad Valorem Tax for Fiscal Year 2018-2019 at

General Manager West gave the staff report. Each fiscal year the Agency must notify the County of San Bernardino Auditor/Controller of the Bighorn Mountains Improvement District 1 (BH ID 1)

special assessment to the tax rolls. This assessment is necessary to generate the revenue for the annual bond payment and a repair/refurbishment fund to maintain the BH ID 1 water system which was constructed with a fixed interest rate, forty-year bond, purchased from the United States of America acting through the Farmers Home Administration (FMHA). The Agency must submit a preliminary Notification of Special Assessment by June 30, 2018, with final submission due August 10th. The fiscal year 2018/19 budget includes the BH ID 1 Ad Valorem tax levy in the amount of \$0.00. The zero dollar budget line item was adopted since this is the final year of debt service and the Board recognized that over the years the County of San Bernardino has collected more than requested due to the reduction in rate of tax delinquency. In other words, the County assumes 8% tax delinquency rate and it has been lower thus the Agency has collected additional funds that can now be used to pay the final year of debt service. The County of San Bernardino has requested the Agency submit a Resolution specifying the amount of collection at \$0.00. This is the final year for payment of the ID1 Debt Service which was issued in 1979 to pay for the water system North of Reche Rd. and West from Gibraltar St.

An anonymous member of the public asked what the original bond amount was. General Manager West answered that it was approximately 1.8 million dollars.

Another anonymous member of the public asked what the interest rate on this loan was. General Manager West answered that it is a 5% flat fixed interest rate. The anonymous member of the public asked for the total amount paid in interest and General Manager West responded that she would have to look that up and could not provide an answer at that time.
