Agency Code of Conduct for the Members of the Agency Board of Directors

General Manager West explained that the Code of Conduct for the Board, which determines how the Board acts as a whole. It also determines how the Board treats one another, interacts with staff and also members of the public. General Manager West noted that in order to make sure everyone is aware of the Code of Conduct, it is important to review it annually with the Board. General Manager West explained to the Board that they will need to sign a form documenting that they have read the Code of Conduct. Reviewing the Code of Conduct will also help qualify the Agency for a District of Distinction Award, which is an award given out by the California Special Districts Association to agencies that are meeting different goals like Agency Transparency, Governance Trainings, and Ethics Training. This is information only and does not require any formal motion.

Reimbursement to County of San Bernardino for Overpayment of Unitary Tax Allocation to Improvement District 1 (Bighorn Mountains) from Fiscal Year 2006/07 through 2016/17 in the Amount of \$130,183.35 with Repayment either as a Lump Sum or Amortized Over 5-years

General Manager West explained that for a number of years, the Improvement District 1 has received more tax allocations than what was originally requested. General Manager West noted the reason for the over collection. Basically, the County sets the tax rates and they factor in an expectation of delinquency. In order to collect the amount of money that is requested, the County has set the rate to 8% delinquency. General Manager West explained that in July, the Agency would be using the extra funds to pay off the rest of the ID1 debt and stop collecting the tax from the community. The County then requested for the overpayment of \$130,183.35 to be paid back. General Manager West explained that in order for the public to not be affected by this, the Agency will make sure the money gets paid back. General Manager West noted that the decision on how to make the payment is left to the board to decide, but General Manager West did recommend to the Board to amortize the amount owed over a 5 year 0% interest repayment plan.

Director Staley asked if the amount owed is accurate, Director Staley also asked why the Agency is recommending the 5 year loan repayment option. General Manager West noted that the Agency does have the funds available to pay this off now, but if the Agency stretched out the payment plan for 5 years, the Agency has a chance to still make money off of the interest while it sits in the bank. General Manager West also told Director Staley that the amount due is accurate.

An anonymous member of the public made a comment about the County of San Bernardino.

An anonymous member of the public asked why it took so long for the County to mention the overpayment. General Manager West explained that the County has known since 2016/2017 but just recently let the Agency know about it.
