Request for Bill Relief from Owner Located at Assessor Parcel Number (APN: 0630-211-XX) Due to "Theft".

No ne attended on behalf of the property owner. General Manager West informed the Board that when a customer receives a high bill and asks for an adjustment, the customers are informed that there are no such policies in place to provide any kind of bill relief. When the discussion continues and the customer wants to speak to someone above the General Manager, they are informed that they have an opportunity to come before the Board to appeal their bill. In this situation, the customer explained to the Agency that someone broke into the home and turned on the hose bib before leaving. An estimated \$400.00 worth of water was released out of the hose bib before the care taker of the property found it.

Vice-President Corl-Lorono asked if the customer knew who left the water on. GM West explained that a police report was filed and someone was arrested a few days later on the property. VP Corl-Lorono stated that this seemed like more of a legal matter between the owner and the person who was arrested.

Secretary Burkhart explained that since the property is being used as business (AirBnB), he thinks the property owner should take this up to with their business insurance. President McBride agreed with Sec. Burkhart and followed up by mentioning that this is what home owners insurance/business insurance is for.

An anonymous member of the public asked why the letters provided have redactions. General Manager West explained that for the safety and anonymity of the owners information, the Agency decided to redact the information from the letters. Another anonymous member of the public expressed their dismay regarding the redacted portions of the letters. Secretary Burkhart explained to the public that the owners information on the letters is not what the Board is there to discuss, the Board is there to determine if the owner will be receiving bill relief or not.

Agency's Appropriation Limit for Fiscal Year 2019/20

General Manager West gave her report to the Board. The Appropriation Limit has to be adopted by Resolution but prior to adoption, Government Code Section 7910 requires that the calculations made to determine the Agency's Appropriation Limit be made available to the public for at least 15 days prior to the date the Board considers adoption of the Resolution. The calculations were posted in the same locations as a Board agenda on May 24, 2019. The calculated Appropriation Limit for Fiscal Year 2019/20 is \$171,668.08. The FY 2019/20 budget projection for the general property tax levy is \$136,330 which does not exceed the reported Appropriation Limit.

Y Y Authorize General Manager to Enter into a Professional Services Agreement with PaleoWest Archeology in the amount of \$73,000 to Perform Paleontological, Cultural and Biological Surveys in Support of the CEQA/NEPA Processes for the Proposition 1 Projects Outlined in the Preliminary Engineering Report

General Manager West gave her report. The Agency has been granted \$500,000 to develop a long term plan to physically interconnect the Improvement District Goat Mountain water system with the Bighorn-Desert View Water Agency water system, provide interties with Hi-Desert Water District, a blending pipeline to reduce Uranium levels and associated improvement projects. The plan is outlined in the Preliminary Engineering Report completed by the Agency's consultant NV5. The next step in the process is to complete the planning activities including right-of-way, project designs and environmental compliance. In order to achieve the environmental compliance under CEQA/NEPA (California Environmental Quality Act/National Environmental Policy Act), staff developed a Request for Proposals (RFP) for paleontological, cultural and biological surveys needed to support the CEQA/NEPA process. PaleoWest Archeology was determined to be the best overall proposal at a cost of approximately \$73,000 for all three requested survey components.

An anonymous member of the public asked if the Agency was looking at other options for the uranium treatment besides the blending that was mentioned. GM West explained that out of the other treatment options, blending would be the most cost effective way to reduce uranium levels over a long period of time.

Vice-President Corl-Lorono made a motion to Authorize General Manager to execute Professional Services Agreement(s) with PaleoWest Archeology, following finalization of scope and fee, to provide paleontological, cultural and biological survey services to support the CEQA/NEPA (California Environmental Quality Act/National Environmental Policy Act) efforts related to Proposition 1 Planning Grant activities at a cost of \$73,000. Director Coulombe seconded the motion.
