Conference Call with Mojave Water Agency's Legal/Legislative and Public Information Committee

Committee participated via teleconference for an update by the State Advocate of Issues at the State Level, as well as an update by the Federal Advocate of Issues at the Federal Level.

California Water Systems Alliance Update

General Manger West gave an update to the Committee regarding the California Water Systems Alliance (CWSA). GM West and Vice President Judy Corl-Lorono along with some representatives from 29 Palms Water District had a meeting with Senator Grove to discuss top legislative and policy proprieties. Priority issues for Bighorn-Desert View Water Agency included following topics: Compliance Assistance Plans: Urge legislature to require the State Water Board to have a compliance assistance plan for disadvantaged communities and small water systems which works in parallel with the approval of new drinking water standards; Streamlined State Grants: improve the process of issuing state grants and loans to water agencies,

particularly those serving disadvantaged communities; Transparency in Adoption of Drinking Water Standards: require transparency in the adoption of Drinking Water Standards that disclose the cost per capita of reducing long-term cancer/health risks; Greater Representation through Elected Officials who Represent Disadvantaged Communities: Agency would like to see greater emphasis on the selection of persons elected by the people in disadvantaged communities who serve on water boards for such appointments; Local-Approach in Water System Needs Assessments: Encourage greater cooperation between state and local initiatives in the development of need assessments.

Emergency Supply Agreement with Hi-Desert Water District (Draft)

General Manager West gave her report. The Agency needs an Emergency Supply Agreement with Hi-Desert Water District (HDWD) which would create and adequate safe drinking water supply that would serve both HDWD and the Agency on an "as needed" basis in the event of an emergency.

Prop. 1 / Round 1 Grant Application Update

General Manager West gave her report. The Agency has been participating in the formulation of a grant application for Proposition 1 Phase 1 funding. This funding opportunity has a little less than \$8,000,000.00 to be distributed in the Colorado Region of the State Water Resources Control Board. The Agency chose to request funding for the replacement well at Goat Mountain because of the low cost of the project (\$500,000.00) and simple CA Environmental Quality Act (CEQA) processes. The Agency would need to pay \$6,100.00 in order for the grant documents to be written. The Committee feels that the \$6,100.00 would be worth spending for the grant request document.
