### **Discussion and Action Items**

### 1. Community Water Systems Alliance Update

GM West reported that the Alliance is regrouping for the new legislative session and has added new members who are being introduced to our format on legislative action as being "proactive", "reactive" or "opportunistic" so that we can prioritize our actions based on our collective perception of the issue at hand.

## 2. Conference Call with Mojave Water Agency's Legal/Legislative and Public Information Committee

The Committee participated via conference call to receive an update on the current status of state and federal legislative issues.

### 3. Prop. 1 / Round 1 Grant Award (Goat Mountain Replacement Well) Update

GM West reported that the Agency has submitted all documents requested by Mojave Water Agency in connection with the grant award. She expects the grant award is now imminent. A meeting with the engineer has been scheduled to finalize the plans and specifications for the project so that it can be released for public bid as soon as the possible.

### 4. Prop. 1 Planning Grant Project (Uranium Blending Pipeline & Consolidation) Update

GM West reported that staff has finalizing the work plan for exploratory trenches with the San Manuel Band of Mission Indians under the required AB52 consultation process. The field work is expected to begin soon. Once the exploration is completed then we will refocus on the entire CEQA document bringing it to the public for the formal comment period. Thereafter the Board would set the date of the Public Hearing to consider adoption to complete the CEQA process. The Agency will then focus on funding opportunities for the project.

### 5. ID Goat Mountain Tanks R1, R2A and R2B Project Update

GM West reported that since project award, the contractor has spent all that time in the shop fabricating the various components, ladders, hatches and railings, for installation in the field. On Monday, October 19, 2020 the contractor mobilized to begin installation of the components on the three tanks. The work is expected to be completed by the end of the week.
