APPROVAL OF AGENDA

McBride made a motion to approve the agenda as presented. McKenzie seconded the motion. Unanimously approved.

Discussion and Action Items -

1. Consideration of Adoption of a Mitigated Negative Declaration (MND) Pertaining to the Potable Water System Improvements and Consolidation of Water Systems for the Bighorn-Desert View Water Agency

GM West gave the staff report as provided in the agenda packet. The Mitigated Negative Declaration draft document was circulated in February 2021. Public Workshops were held in March and April 2021. As of the start of this meeting, staff is not aware of any public comments being submitted to the Agency. GM West stated that the action before the Board tonight is to accept any public comments and then to take action to either adopt or decline to adopt the Resolution.

GM West introduced Mr. James Owens, PE, of NV5 who is managing the planning grant process on behalf of the Agency so that any questions from the Board could be addressed.

Vice President McBride made a motion to adopt the Mitigated Negative Declaration (MND) pertaining to the Potable Water System Improvements and Consolidation of Water Systems (SCH 2021020354). Director Dicht seconded the motion.

2. Fiscal Year 2021/22 Property and Casualty Insurance and Workers' Compensation Insurance Program: Recommendation to Join CalMutuals /JPRIMA-Allied Risk; and to Join CalMutuals as a condition of JPRIMA; and engage Liebert Cassidy Whitmore as Special Counsel to the Agency on Personnel/Human Resource Matters; and to Notify Special Districts Risk Management Authority of the Intent to Withdraw from Coverage Effective July 1, 2021

GM West gave the staff report as provided in the agenda packet. She noted that the Finance Committee held two meetings regarding staff's recommendation to consider an alternative insurance package. GM West stated she believes that all outstanding questions

asked prior to the meeting tonight have been answered. She further stated it was her understanding that the Finance Committee is moving this recommendation to the full Board for consideration and approval.

GM West introduced Mr. Paul Fuller, Allied Public Risk, LLC to answer any further questions of the Board.

Director Dicht's commented on the subject and noted his questions have been answered. He asked for a summary of what JPRIMA is and what the Agency is signing up for. Mr. Fuller gave a brief overview of JPRIMA and the policy noting that Allied Risk is focused on water and wastewater entities only. He further discussed the LCW relationship strategy. Finally, the policy also reflects an increase in liability to \$5M from \$2.5M.

Motion No. 21-026

Vice President McBride made a motion to join CalMutuals /JPRIMA-Allied Risk; and to Join CalMutuals as a condition of JPRIMA; and engage Liebert Cassidy Whitmore as Special Counsel to the Agency on Personnel/Human Resource Matters; and to Notify Special Districts Risk Management Authority of the Intent to Withdraw from Coverage Effective July 1, 2021. Secretary McKenzie seconded the motion.

3. Resolution No. 21R-10 Rescinding Resolution No. 21R-01 and Adopting an Increased Basic Facilities Charge (Water Capital Fee) for Water Meters Size %-inch to 10-inch

GM West gave the staff report as outlined in the agenda packet. She apologized for the oversight in timing of the implementation and was certainly surprised as the execution of the charge has never been challenged before now. She reported that anyone who purchased a meter prior to the 60-day wait period has received a refund. In addition, any person who submitted a written request to obtain a meter, subsequent to the passage of the resolution and prior to the 60-day waiting periods conclusion, were contacted and informed of the matter coming before the Board tonight.

Vice President McBride asked when the new resolution would be effective. GM West stated it would be effective July 12, 2021. Director McKenzie asked about the flow through a larger meter.

Secretary McKenzie made a motion to adopt Resolution No. 21R-10 Rescinding Resolution No. 21R-01 and adopting an increased Basic Facilities Charge (Water Capital Fee) for water meter size ¾-inch to 10-inch. Vice President McBride seconded the motion.

GM West gave the staff report as provided in the agenda packet and a PowerPoint presentation identifying the location of the property. She noted that Ms. Tsaconas is present via Zoom should the Board have any questions.

Ms. Tsaconas asked about getting the lower meter cost as well as other questions on the process. GM West responded that the annexation would not be completed in 60-days and that being from outside the Agency boundaries the "new" rate is actually the correct fee for a property that has never paid anything to the Agency throughout its history.

9. Public Comment Period

An anonymous member of the public asked about water supply from Big Bear, CA.

Mr. Sundstrom commented on "illegal" pot farms and water supply. He wants to know how the Bighorn-Desert View Water Agency can support law enforcement in this efforts. Provide water and then look the other way. He mentioned the Sheriff and those things that are in the purview of the water company. He mentioned the bust from last week. Can water be suspended/cut-off from these parcels, they have violated state and county laws. Is it unreasonable for the public to think the water agency can assist law enforcement and cut off water to these accounts. I have done some research and we do have "good cause" rights to cut service. What is good cause? An illegal business something that is totally illegal.

Ms. Burkhart commented that she understands the gentlemen's concerns and anxieties about it however the Agency cannot be involved in law enforcement and there are state laws that require the service to be provided. The Board can have a request from people who don't pay bills and the agency still has to provide water. The Agency has no legal means to deal with it. It is the sheriff's job and we don't have enough law enforcement to go around.

Mr. Sundstrom responded that he knows the Board is not a law enforcement agency. What can be reasonably done to support law enforcement. What type of unintended consequences when we believe we are doing something right? Little insane to provide water and then the sheriff's bust them and water stays on. Maybe look to other agencies to see what they are doing.

Director McKenzie asked that once the sheriff has raided a property it was because they were doing something illegal.

President Burkhart stated that each time a search warrant is needed and that time and research is way beyond our resources.

An anonymous member of the pubic commented on the carbofuran being brought in from Mexico and it is deadly.

- 10. Verbal Reports Including Reports on Courses/Conferences/Meetings.
 - General Manager Report Reported on the focused preventative maintenance the Operations Crew is executing including valve maintenance and fire hydrant maintenance in addition to regular duties. She also noted that the administrative staff is preparing for the new billing rates and pre-audit with the full audit scheduled for August 1, 2021.

GM West reviewed portions of a memo sent by Assy. Smith to Assy. Ting – Assembly Budget Committee asking for additional funding to County of San Bernardino Marijuana Enforcement Team in the amount of \$978,000.
