1. Review Mojave Water Agency's Legal, Legislative and Community Partners Committee Meeting Held March 8, 2022

Committee reviewed portions of prerecorded teleconference for an update by the State Advocate of Issues at the State Level, as well as an update by the Federal Advocate of Issues at the Federal Level.

2. Status Update Proposition 1 Planning Grant

GM West gave the update noting that this project is scheduled to be closed by the end of June 2022.

3. Status Update Goat Mountain Replacement Well, Destruction of GM Well 2 and Up to Three Additional Borings/Monitoring Wells

GM West gave the update as provided in the agenda packet report.

4. Drought Grant Award \$235,000 for Residential Water Meter Replacement Program – Verbal Update

GM West informed the Committee the Agency was awarded this grant through the drought assistance program and is working with Provost and Prichard to assist with the development and execution of the contract documents needed for this project.

5. Ames/Reche Recharge Project - Verbal Update

GM West informed the Committee of a project proposed by Hi-Desert Water District which would expand the Ames/Reche Recharge Facility to accommodate additional recharge capacity. The project would include another HDWD production well for redundancy. HDWD has expressed a desire to operate and maintain the recharge facilities once the expansion is complete. GM West acknowledged the comment and stated that she requested HDWD develop a Memorandum of Understanding which outlines the proposed project and commitments being verbally expressed by HDWD.

Chair Burkhart expressed opposition to HDWD operating and maintaining the Ames/Reche Recharge Facility.
