 Public Budget Workshop - Fiscal Year 2022/23 Budget Resolution No. 22R-06 – Resolution Fixing and Adopting the Budget for Fiscal Year 2022-2023 for the Bighorn-Desert View Water Agency

She noted the only updates from the Finance Committee was a request to consider a higher budget for both fuel and power given the draft budget had applied only a 5% increase.

#### 9. Public Comment Period

Ms. Domay asked about permitting of private wells in the Agency boundaries and about water quality. She also inquired about how many Agriculture accounts have a past due balance. GM West responded that the number is around ten and will be brought to the Board on July 12<sup>th</sup> for the Public Hearing.

A member of the public talked about water conservation and state limits that may be imposed and groundwater aquifer levels. He argued there needs to be latitude. He is concerned that the state is not considering local conditions and our own groundwater levels.

- 10. Verbal Reports Including Reports on Courses/Conferences/Meetings.
  - General Manager Report The Consumer Confidence Report will be ready for distribution by the July 1, 2022 deadline. This year is our triennial Lead and Copper testing conducted by residents at a home water tap.

# 2. Director Reports

Director Close-Dees reported on the May 19<sup>th</sup> Homestead Valley Community Council meeting. Highlights included Morongo Basin Historical Society updates; FP-5 Fire Tax and a push to vote "no" which would keep the tax and some background on how the FP-5 operates by Captain Munsey; there was an update on fentanyl in the County; a Red Cross program providing free smoke detectors.

Director Dicht reported on the Homestead Valley Community Council meeting of June 20<sup>th</sup> where they discussed a wildfire in Wrightwood, a house fire in Landers, the smoke alarm grant and current status of burn permits; reminder that fireworks are illegal in the County of San Bernardino. Sup. Rowe reported on the RoBott Land Company proposal coming before the Planning Commission. She stated that she recommended that they come to an HVCC meeting in the future to address the public's concern. She further discussed the Short Term Rental changes forthcoming, which are numerous. Concerning the Transient Occupancy Tax (TOT) it is funneled directly to the County General Fund and not to specific communities. She did mention that the TOT in Lake Arrowhead is far greater than Joshua Tree for comparison. The final update was on the "listing" of the Joshua Tree as an endangered species. Sup. Rowe's expectation is that this will ultimately pass. Hwy 247 Scenic Highway designation is still progressing albeit slowly.

Director Chapman reported on the June 9 Mojave Water Agency meeting which highlighted the Water Banking strategy. They believe they have up to 1 million acre-feet of storage capacity and would like to utilize it to store water on behalf of other entities, such as Metropolitan Water District. He discussed various

aspects of the program pros and cons brought up by the MWA Board of Directors and public.

President Burkhart reported on the MWA Technical Advisory Committee held June 2<sup>nd</sup>. The meeting topics included the Water Banking update and a summary of the grants awarded under the Drought round and Prop. 1/Round 2 and an update on Operation Hammer Strike and various legislative bills before the Legislature this year.
