RESOLUTION OF THE BOARD OF DIRECTORS OF THE BIGHORN-DESERT VIEW WATER AGENCY ESTABLISHING THE APPROPRIATION LIMIT OF THE AGENCY AT \$177,849 FOR THE FISCAL YEAR JULY 1, 2020 – JUNE 30, 2021 PURSUANT TO ARTICLE XIIIB OF THE CALIFORNIA CONSTITUTION

WHEREAS, the California Constitution and Government Code Section 7900 et seq. requires the Board of Directors to annually calculate and establish, by resolution, the Agency's appropriations limit for each fiscal year; and

WHEREAS, the calculations made to determine the appropriations limit was made available to the public on June 5, 2020 for at least 15 days prior to the date of this Resolution, in accordance with Government Code 7910.

NOW, THEREFORE, THE BOARD OF DIRECTORS HEREBY RESOLVES:

- 1. That the appropriations limit of Bighorn-Desert View Water Agency for fiscal year July 1, 2020 June 30, 2021 was calculated at \$177,849; and
- 2. That the fiscal year 2020/21 budgeted revenue from property taxes is \$136,330 which does not exceed the calculated appropriation limit.
