

RESOLUTION NO. 21R-15

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE BIGHORN-DESERT VIEW WATER AGENCY CONFIRMING REPORTS OF DELINQUENT ACCOUNTS FOR BASIC SERVICE CHARGES, WATER CONSUMPTION CHARGES, REVENUE BOND SURCHARGES, DELINQUENT FEES, MISCELLANEOUS FEES AND PROCESSING FEES AND AUTHORIZING THE PLACEMENT OF PROPERTY LIENS ON THE SECURED TAX ROLLS OF SAN BERNARDINO COUNTY FOR COLLECTION OF DELINQUENCIES WITHIN BIGHORN-DESERT VIEW WATER AGENCY

WHEREAS, annually the Bighorn-Desert View Water Agency makes a determination of the number of delinquent accounts that have been flagged for possible application of a property lien on the secured tax rolls of San Bernardino for collection of unpaid balances.

NOW THEREFORE BE IT RESOLVED that the Board of Directors of the Bighorn-Desert View Water Agency resolves as follows:

SECTION 1: The Board of Directors of the Bighorn-Desert View Water Agency finds and declares as follows:

- A. On June 1, 2021 the General Manager did cause written notification to be mailed, by first class U.S. Mail, to those delinquent customers listed below and that public notices would be placed in the local newspaper as the final attempt to notify them and that a public hearing would be held on July 13, 2021; and
- B. On June 16, 2021, such public notices to those delinquent customers listed below were placed in the local newspaper and published on June 23, 2021 and published on June 30, 2021.

SECTION 2: The Board of Directors of the Bighorn-Desert View Water Agency resolves that the following delinquent accounts will be placed on the (2021/22) Secured Property Tax Roll of the County of San Bernardino Tax Collector as authorized by law, including, without limitation, pursuant to Bighorn-Desert View Water Agency Law (Act 90 of the Water Uncodified Acts):
